Family Specialists provided family support at 19 court hearings, and 211 Child and Family Team/Wraparound meetings statewide. Provided compassion and understanding of the unique experiences and needs of children and families while helping find the information, support and resources needed at home, in the community and at school. In addition Nevada PEP held monthly family to family support group meetings providing the opportunity for networking, sharing of resources, and peer support.

Nevada PEP is a family driven organization dedicated to educating parents and professionals throughout Nevada's 17 counties. Nevada PEP offers services through the Neighborhood Family Service Centers and is a collaborative partner in the Children's Mobile Crisis Response Teams Division. Nevada PEP believes that the family is the fundamental unit in society, children with disabilities without regard for the severity of the disability, have an inherent value, that all life has a purpose, that communities benefit from providing appropriate interventions and that individuals with disabilities make a valuable contribution to society. In this fiscal year Nevada PEP has provided trainings, free of charge, to over 2,432 individuals, 95% of participants reported that the workshops provided them the information they needed to make decisions about their child's education.
