Nevada PEP Family Specialists provided education, advocacy, information and referral services to assist families in accessing services. Family Specialists provided family support at 23 court hearings, and 177 Child and Family Team/Wraparound meetings statewide. Provided compassion and understanding of the unique experiences and needs of children and families while helping find the information, support and resources needed at home, in the community and at school. In addition Nevada PEP held monthly family to family support group meetings in both English and Spanish providing the opportunity for networking, sharing of resources, and peer support.

During this period, Nevada PEP supported families and youth with disabilities to attend Statewide conferences on transition to adulthood and educational best practices.
